SURFACE PREPARATION

NEW HARDWOOD	Ensure timber surface is dry, clean and free from dirt and debris prior to application
SOFTWOODS: TREATED PINE & WESTERN RED CEDAR	Ensure timber surface is dry, clean and free from dirt and debris prior to application
PREVIOUSLY STAINED OR OILED TIMBER	Ensure timber surface is dry, clean and free from dirt and debris prior to application

APPLICATION

STIRRING	Shake container prior to using
EQUIPMENT	Watering Can, Stiff bristle brush
APPLICATION METHODS	Apply undiluted to timber (suggest using a watering can or sprayer which will provide a good spread on decking boards). Alternatively Johnstone's Tannin & Oil Remover can be poured into a bucket or roller tray and applied using an applicator pad. Scrub solution into the timber using a stiff bristle brush. Spot applications should be avoided to prevent patchy results. Leave Johnstone's Tannin & Oil Remover on the timber for 10 – 15 minutes. If necessary apply more product or a light spray of water to keep the surface damp throughout this period. Do not allow Johnstone's Tannin & Oil Remover to dry on the timber surface. Rinse off exterior timber surfaces thoroughly using maximum pressure from a garden hose or using a high pressure water cleaner.

STORAGE INFORMATION	Store in original container protected from direct sunlight in a dry, cool and well-ventilated area. Do not store below 5°C temperature. Keep containers sealed when not in use

Disposal of empty paint containers via domestic recycling programs may differ between local authorities. Check with your local council first
